NOTICE

As per the provisions of the Scheme for the Management and Administration of Shivaji Park Gymkhana, Notice is hereby given for elections for the posts of President, Three Vice Presidents, and 15 members of the Managing Committee for the period from 2024 - 2027 and three posts of Trustees for the period from 2024 - 2030.

Nominations are invited from the members of the Gymkhana, eligible to contest the elections as per clause 54 of the Scheme for the Management and Administration of the Gymkhana for the following posts duly proposed and seconded by the members eligible to nominate and vote on the date of nomination of the year of election and countersigned by the contesting candidate in token of his/her consent in the prescribed form issued by the Office of the Gymkhana at Prakash Building, Opp, Brahman Sahayak Sangh, Shivaji Park, Dadar West, Mumbai – 400028. The following are details of Election procedure which will be followed.

- 1) Issue of Nomination forms. From 10/05/2024 to 21/05/2024 up to 3.00 p.m.
- 2) Receipt of Nomination forms From 10/05/2024 to 25/05/2024 up to 5.00 p.m.
- 3) Scrutiny of Nomination forms by the Returning Officer on or before 05/06/2024
- 4) List of eligible candidates to be put on the Notice Board 07/06/2024
- 5) Withdrawal of Nominations Form 10/06/2024 up to 5.00 p.m.
- 6) Final list to be put on Notice Board 12/06/2024
- 7) Elections, if necessary, will be held on 30/06/2024 Sunday 8.00 a.m. to 7.00 p.m. at "Scout Hall", Shivaji Park, Dadar (W) Mumbai 400028.

No member shall offer himself/herself for more than one post of the Management of the Gymkhana. Only one prescribed form shall be issued per member.

- 8. Only one Nomination form will be issued to a member from the Office of the Gymkhana.
- 9. A Member is eligible to contest for one post only.
- 10. Retired or Retiring member is eligible to re-contest provided he/she is not prohibited from contesting election as per the Rules and Regulations of the Scheme.
- 11. No Trustee whose term has not expired at the time of invitation of nominations, shall be eligible to contest for any other post on the Management unless and until he/she resigns as a Trustee before filling nomination for any other post.
- 12. No member, who has not been on the roll of the Gymkhana as a Member for a period of five years prior to the date of nomination or who is in arrears of subscription for a period of three months or more, shall be eligible to nominate or contest the election of the Management of the Gymkhana.
- 13. A member who has not completed five years on the date of nomination from the date of his admission, a member who is in arrears of subscription for three months or more or a member who is suspended under Rule 12(g) or a member who is a defaulter under Rule 9(h), Student member, member below 18 years, member under Rule 6(F), Corporate member, Associate Member, Widows/Widowers under Rule 6(J) and Dignitary member under Rule 6(K), member under rule 6(L) shall have no right to contest in any election of the Gymkhana nor he/she be eligible for any post on the Management of the Gymkhana.
- 14. For the post of President, Vice Presidents, a member shall not be eligible to contest for the said post till he/she completes ten years as a member of the Gymkhana.
- 15. For the post of Trustee, a member shall be Patron or Life member of the Gymkhana for a minimum period of ten years.
- 16. The Cricket Constituency shall comprise of Members of at least five year standing and who are not in arrears for more than three months. The person should have played in MCA affiliated tournaments for at least two seasons. Only members fulfilling requirements of this clause are eligible to contest for the Cricket Secretary and Cricket Member Election.(Clause 29b)
- 17. Tennis Constituency shall comprise of Tennis Members of at least Five years standing and who are not in arrears for more than three months. Only members fulfilling requirements of this clause are eligible to contest for the post of Tennis Secretary and Tennis member.
